

**CALL FOR STATEMENTS OF INTEREST (unofficial translation)**

Art. 7, paragraph 5 bis, Law 30-12-2010, n. 240

The Department of Law of the Università degli Studi Roma Tre, consistently with its development project as Department of Excellence and aiming to strengthen its profile in the international context with reference to both teaching activity and research, is seeking to fill a tenured position at the level of full professor (*Professore Ordinario*) in the field of business law (*Diritto commerciale*), s.s.d. IUS/04, with particular regard to the transnational protection of cultural heritage in the context of the protection of intellectual property, with special focus on digitalization, artificial intelligence, respect of human rights, also in the sense of reducing social inequalities.

In particular, the Department wishes to involve the applicant in the following areas:

- Courses entirely taught in English
- Courses taught in Italian
- Legal clinics
- European and international research projects
- Dual degree programs with foreign academic institutions.

Applications are invited from scholars meeting the requirements envisaged by art. 7, paragraph 5 bis, l. 30 December 2010, n. 240 (*"Universities can recruit full and associate professors who have been in service for at least five years at other universities in the position corresponding to that for which the selection is announced, or scholars permanently engaged abroad in research or teaching activities, who have held an equivalent academic position at foreign universities for at least five years on the basis of correspondence tables defined and updated every three years by the Minister of Universities and Research, after consulting the National University Council, by carrying out selective procedures aimed at evaluating which project proposals best fit the didactic, research or third-mission needs expressed by the universities. With regard to the position of full professor pursuant to the first paragraph, candidates are required to meet the requirements of current legislation for aspiring commissioners for national scientific qualification procedures, referred to in Article 16"*).

Considering the natural transnational dimension of the issues of interest, as described above, candidates should have an established track record of publications of international dissemination and be able to prove participation in important domestic and/or international research projects, excellent evaluations in courses held, and experience in teaching in institutions (foreign institutions included), different from the one to which they belong.

All the aspects concerning salary, teaching loads, and legal status are regulated by the relevant Italian laws and by the by-laws of Roma Tre University and of the Department of Law.

Those interested who belong to foreign academic institutions are invited to verify, in advance, all pension and social security issues.

The person who will be selected by a specific Commission is expected to teach within courses that are entirely taught in English, therefore full knowledge of English language is requested. Furthermore, teaching activity is also programmed in the Italian law degree course (*Laurea magistrale in giurisprudenza* - LMG/01). In that respect, knowledge of Italian is required.

Expressions of interest can be written in Italian or in English and must contain: a) a project proposal explaining the candidate's scientific profile, teaching methods and research fields (max. 1500 words); b) curriculum vitae and list of publications; c) declaration in lieu of certification (art. 46 d.p.r. 28 December 2000, n. 445) concerning the possession of the requisites envisaged by art. 7, paragraph 5 bis, l. 30 December 2010, n. 240).

The submission of the application is valid exclusively for the purpose of expressing interest in this call and does not give the right, in any case, to be admitted to the recruitment procedures of Roma Tre University.
